#### Who Can Apply

Open to all government of Guam employees and the public.

## Qualification Requirements

Two (2) years of experience as a licensed driver operating standard motor vehicles and graduation from high school;

Any equivalent combination of experience and training which provides the minimum knowledge, abilities and skills.

## Necessary Special Qualifications

Possession of a valid Guam driver's license.

## Nature of work

This is routine driver's licensing examining work involved in testing and evaluating applicants for motor vehicle operators and/or chauffeur's licenses. Employees in this class conduct standardized examinations to determine skill and competence of driver's license applicants independently after initial training and works under closer supervision on a variety of more complex assignments.

## **Illustrative Examples of Work**

Administers the written and oral tests to applicants to determine knowledge of Government of Guam Vehicle Code and traffic sign interpretations; administers color and depth perception, peripheral and other tests of vision. Conduct practical driving test for applicants on an approved testing-site or on a selected of road; evaluates applicant's alertness to and compliance with traffic laws, road signs and other basic rules of the road. Evaluates applicant's test performance according to standard measures, notifies applicants of examination results and suggest improvements to failures. Checks motor vehicle for inspection stickers, lights, windshield wipers, seat belts and other mechanical features for safety while in operation. Assists in the examination of heavy equipment operators or other non-standard size vehicles. Explains the Vehicle Code of Guam relative to driver's licensing and concerning requirements. Operates photographic identification equipments and computer testing machine. Operates computer terminal to inquire and/or update on an on-line system. Performs related duties as required.

## Knowledge, Abilities & Skills

Knowledge of the Vehicle Code of Guam relating to driver's licensing. Ability to conduct the standard tests used in driver's examination fairly and impartially. Ability to explain the provisions of the Vehicle Code of Guam relating to driver's licensing. Ability to work effectively with the public and employees. Ability to communicate effectively, orally and in writing. Ability to operate various types of equipment used in testing applicants for driver's licensing. Ability to operate various types of equipment used in testing vehicles with standard and four-speed transmissions.

## Minimum Educational Requirements

All new employment in the service of the government of Guam shall have, as a reasonable measure of job performance, minimum requirement of high school diploma or a successful completion of General Education Development (GED) test or any equivalent of a general education high school program, apprenticeship program or successful completion of a certification program, from a recognized, accredited or certified vocational technical institution, in a specialized field required for the job, pursuant to Public Law 29-113.

## **Documentation Requirements**

To validate credentials you may claim, (e.g., High School Diploma, College Transcript, DD-214, etc.), an original or certified copy of the document(s) must accompany each employment application you are applying for with your legal signature. Applicants shall be responsible to provide all required documents for each employment application submitted and failure to provide proof may result in disqualification. ## **Suitability Determination Form**

Your employment application will not be deemed completed unless the Suitability Determination Form is completely filled out, signed and dated. If it is not complete or missing from your application, your application for this position will be rejected. Please pay particular attention to question #2. If you answer "yes", you must attach your police clearance that is no older than one (1) month from the date of submitting your application. In addition, please resubmit an updated Suitability form if anything occurred that warrants updating your responses on your Suitability Form after you have submitted your application.

# DRIVER'S LICENSE EXAMINER I OPEN COMPETITIVE EXAMINATION

## Prohibition Pursuant to P.L. 28-98

No person convicted of a sex offense under the provision of chapter 25 of Title 9 GCA, or an offense as defined in Article 2 of Chapter 28, Title 9 GCA in Guam, or an offense in any jurisdiction which includes, at a minimum, all of the elements of said offenses, or who is listed on the Sex Offender Registry shall work in any agency or instrumentality of the government of Guam.

## **Examination Requirements**

Applicants will be rated on a scale between 70.00 and 100.00 percent on the basis of their training, education and experience in relation to the requirements of the position.

#### **Interviewing Procedures**

A personal interview or interview by telephone (if off-island) will be held by the appointing authority or his designee for all eligibles referred via certification.

## **Employment Medical Examination**

All applicants accepting employment must undergo a medical examination and be declared by the physician as capable of performing the duties of the position being hired for.

#### Work Eligibility

When offered a position, you will be required to provide proof of identity and eligibility for employment in the United States as condition of employment.

#### **Drug Screening**

Applicants selected for and offered employment with the Government of Guam shall undergo and pass a mandatory drug test before being employed; this also applies to employees selected for Test Designated Positions (TDP). Failure to submit or pass such drug test shall be grounds for rescinding the offer of appointment. In addition, persons who have applied for, or are seeking reemployment/reappointment in the government and previously had a non-negative drug test result must meet certain conditions to be re-drug tested for employment. ## Police & Court Clearances Requirements

If selected for this position, your selection will be <u>conditional</u> pending submission of a recent police and court clearance, and taking and passing a drug test (see Drug Screening section of the announcement). The hiring department will mail a letter to you explaining these requirements. You will have five (5) business days from the postmarked date of your letter to submit police and court clearances that are no older than one (1) month from the date of you letter. The cost of the clearances is your responsibility. If you have already submitted clearances with your employment application, you will not be required to resubmit as long as they meet the date criteria above. If you do not have any conviction or conditions that would warrant rescinding the job offer, and pass the drug test you will be notified of your start date.
