Who Can Apply

Open to all government of Guam employees and the public.

Qualification Requirements

One (1) year of professional social work experience and graduation from a recognized college or university with a Bachelor's degree in sociology, psychology or closely related field; or

Graduation from a recognized college or university with a Bachelor's degree in social work; or

Any equivalent combination of experience and training beyond the Bachelor's degree which provides the minimum knowledge, abilities, and skills.

Nature of work

This is moderately complex professional correctional social work. Employees in this class perform moderately complex professional case work of inmates in a correctional institution independently on an ongoing basis and participate in the full range of complex professional duties under closer supervision.

Illustrative Examples of Work

Interviews inmates and other appropriate persons to obtain information on social and criminal history; participates in the formulation and implementation of social work treatment plans; prepares case records and reports. Assists inmates in the development of social attitudes and adjustments. Organizes and leads group discussions, recreation, vocational or forms of creative activity to stimulate interest in group work or cultivate inherent abilities and skills. Observes and evaluates behavior of inmates and prepares reports on the overall progress and social adjustment; makes recommendations regarding alternative placements. Attends conferences and staff meetings for the purpose of discussing individual cases and for cooperative planning of treatment program and improved services. Performs related duties as required.

Knowledge, Abilities & Skills

Knowledge of the principles, practices and techniques of social work. Knowledge of the dynamics of human behavior of individuals and groups. Knowledge of correctional social work programs, regulations and policies and other appropriate resources. Ability to conduct interviews, collect, evaluate and interpret facts and recommend courses of action. Ability to analyze situations and people accurately and implement approved course of action. Ability to maintain an objective and emotionally stable attitude in meeting distressing situations presented by individuals and/or families. Ability to prepare clear, concise case histories and factual reports. Ability to work effectively with inmates, the public and employees. Ability to communicate effectively, orally and in writing. Ability to maintain records.

Minimum Educational Requirements

All new employment in the service of the government of Guam shall have, as a reasonable measure of job performance, minimum requirement of high school diploma or a successful completion of General Education Development (GED) test or any equivalent of a general education high school program, apprenticeship program or successful completion of a certification program, from a recognized, accredited or certified vocational technical institution, in a specialized field required for the job, pursuant to Public Law 29-113.

Documentation Requirements

To validate credentials you may claim, (e.g., High School Diploma, College Transcript, DD-214, etc.), an original or certified copy of the document(s) must accompany each employment application you are applying for with your legal signature. Applicants shall be responsible to provide all required documents for each employment application submitted and failure to provide proof may result in disqualification. **For more information, please contact the Recruitment Branch at 475-1141/1128.**

Suitability Determination Form

Your employment application will not be deemed completed unless the Suitability Determination Form is completely filled out, signed and dated. If it is not complete or missing from your application, your application for this position will be rejected. Please pay particular attention to question #2. If you answer "yes", you must attach your police clearance that is no older than one (1) month from the date of submitting your application. In addition, please resubmit an updated Suitability form if anything occurred that warrants updating your responses on your Suitability Form after you have submitted your application.

CORRECTION SOCIAL WORKER II OPEN COMPETITIVE EXAMINATION

Prohibition Pursuant to P.L. 28-98

No person convicted of a sex offense under the provision of chapter 25 of Title 9 GCA, or an offense as defined in Article 2 of Chapter 28, Title 9 GCA in Guam, or an offense in any jurisdiction which includes, at a minimum, all of the elements of said offenses, or who is listed on the Sex Offender Registry shall work in any agency or instrumentality of the government of Guam.

Examination Requirements

Applicants will be rated on a scale between 70.00 and 100.00 percent on the basis of their training, education and experience in relation to the requirements of the position.

Interviewing Procedures

A personal interview or interview by telephone (if off-island) will be held by the appointing authority or his designee for all eligible referred via certification.

Employment Medical Examination

All applicants accepting employment must undergo a medical examination and be declared by the physician as capable of performing the duties of the position being hired for.

Work Eligibility

When offered a position, you will be required to provide proof of identity and eligibility for employment in the United States as condition of employment.

Drug Screening

Applicants selected for and offered employment with the Government of Guam shall undergo and pass a mandatory drug test before being employed; this also applies to employees selected for Test Designated Positions (TDP). Failure to submit or pass such drug test shall be grounds for rescinding the offer of appointment. In addition, persons who have applied for, or are seeking reemployment/reappointment in the government and previously had a non-negative drug test result must meet certain conditions to be re-drug tested for employment. Police & Court Clearances Requirements

If selected for this position, your selection will be **conditional** pending submission of a recent police and court clearance, and taking and passing a drug test (see Drug Screening section of the announcement). The hiring department will mail a letter to you explaining these requirements. You will have five (5) business days from the postmarked date of your letter to submit police and court clearances that are no older than one (1) month from the date of your letter. The cost of the clearances is your responsibility. If you have already submitted clearances with your employment application, you will not be required to resubmit as long as they meet the date criteria above. If you do not have any conviction or conditions that would warrant rescinding the job offer, and pass the drug test you will be notified of your start date.
