This is in reference to the Government of Guam's Request for Proposal DOA/ID-RFP-GHI-26-001 issued on April 7, 2025 for the Government of Guam Group Health Insurance Program.

This Amendment reflects changes as indicated below.

I. FY2026 GHI RFP- MULTI-YEAR REFERENCES REMOVED AS IDENTIFIED BELOW:

A. Special Reminder to Prospective Offerors amended to read as follows:

- i. Item 3; page 3: To be qualified, pursuant to Title 4 GCA § 4302(c), an offeror shall submit a cost proposal for an annual Third Party Administrator (TPA) contract for an exclusive proposal, and meet the minimum requirements specified in the RFP (see Exhibit A for list).
- ii. Item 6; page 4: All offerors should submit their cost proposal for an annual contract within the original response. The cost proposal would apply under an exclusive arrangement.

B. General Information amended to read as follows:

i. Section A. Purpose and Background, page 8, paragraph 8

1. The Negotiating Team is seeking an annual (1 year) rate quote contract.

ii. Section H. Duration of Contract, page 12

1. The duration of any contract resulting from this RFP shall be an annual year: from October 1, 2025 through September 30, 2026.

- A. Tab 1. Admin costs – FY2026 Medical, Pharmacy, & Dental Administration Costs Self-funded administration cost per employee per month (PEPM) amended as follows:**

- i. Only includes administration cost table for contract year October 2025 – September 2026 (1 year).
- ii. Removed two previous tables that requested multi-year administration costs for contract year October 2025 – September 2028 (3 years).
